Effective dissemination is about getting the findings of your research to the people who can make use of them, to maximise the benefit of the research without delay. NIHR have just produced a new guide to research dissemination. It will be especially useful to researchers applying for funding or who have research in progress. It is designed to help you to plan your dissemination and give your research every chance of being utilised.

NIHR PhD studentships open to applications.

The deadline for applications is 12 noon on Wednesday 9th May 2018.

Applications are invited from individuals with a strong academic record who wish to develop a career in public health research. The NIHR School for Public Health Research is a partnership between the Universities of Sheffield, Bristol, Cambridge, Imperial and University College London; The London School for Hygiene and Tropical Medicine (LSHTM); the LiLaC collaboration between the Universities of Liverpool and Lancaster and Fuse; The Centre for Translational Research in Public Health, a collaboration between Newcastle, Durham, Northumbria, Sunderland and Teesside Universities.

Awards will normally be taken up in October 2018. Applicants must have a first degree in a discipline relevant to public health research and will be expected to complete a PhD during the award period.

This award will fund tuition fees up to the value of Home/EU fees; students with overseas status are welcome to apply but will need to fund the remainder of their fees from alternative sources.

Please note: non UK/EU students should check the requirements of the host institution before submitting an application.

Studentship awards include tuition fees, an annual tax-free stipend of £14,777 and a contribution towards research and training costs. Students at our member universities in London will receive a London weighting.

Entrapment neuropathies, pathophysiology, assessment and management

Participants will be updated on recent advances in the understanding of pathophysiological mechanisms underlying entrapment neuropathies. We will discuss the scientific evidence for mechanisms such as neuro-inflammation in the peripheral and central nervous system, myelin and axon degeneration or cortical changes and put them in relation to common symptoms and signs in patients with entrapment neuropathies. An improved understanding of underlying pathomechanisms will not only facilitate a targeted assessment of these patients but will also have implications for the management and prognosis.

Course Objectives

• To enable the participants to understand the basic principles of pain physiology associated with entrapment neuropathies and to incorporate this knowledge into their clinical reasoning framework.

• To be familiar with the practical performance and interpretations of bedside neurological testing and quantitative sensory testing methods in the context of entrapment neuropathies.

• To understand the available evidence for the efficacy and benefit of physiotherapeutic (and

pharmacological/surgical) interventions in the management of patients with entrapment neuropathies.
